I am a letter carrier, level 6, who was placed by NRP in a mailhandler level 4 position November of 2008 to start January 3rd, 2009 at Palatine P & DC as a mailhandler. I had a job modification to accomodate my restrictions on limited duty in place at the Arlington Heights Post Office and that was before NRP came in and told me I was being reassigned to Palatine P & DC.

I'm capable of delivering mail within my restrictions. I can deliver to curb side boxes, apartment routes, NDCBU'S and businesses. I can still case routes.

I would like to be included in the "Amicus Briefs", to restore my job at the Arlington Heights Post Office as a letter carrier.

I know of people still not removed by NRP on restrictions with less seniority than me whom are still working.

I'm aware of the article regulation at: CFR 353.301(d). I feel that it still not happened and I feel that it's still a violation of the blanket contract protecting injured employees to find work within their restrictions.
